5. Documentation showing Commissioners' in precincts 1 -4 and County Attorney's time away from office for past year and documentation showing time on the clock for county business.



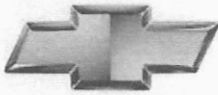
